



The CLUB NAUTICO MORAIRA announces the
celebration of the 300 MILES OF MORAIRA
"GREFUSA Trophy"
For ORC boats over 9 meters (LOA)

1-ORGANIZATION

The XIX edition of the 300 MILES OF MORAIRA is organized by the CLUB NAUTICO MORAIRA, with the authorization of the F.V.C.V.

2-PLACE AND DATES

The XIX Edition of the 300 MILES OF MORAIRA will be held in the waters of Alicante (Moraira), Murcia (Isla Grosa), Formentera, Ibiza, Castellón and Valencia. It will begin on Wednesday 22nd of January 2020, with the attention signal at 11:50 local time.

3-Rules

3.1 The regatta will be governed by:

- a) RRV of the World Sailing 2017-2020 (RRV)
- b) The Technical Regulations of the Royal Spanish Sailing Federation and its prescriptions.
- c) The O.R.C Measurement Regulations
- d) The Special Rules for Offshore Racing of the Offshore Racing Congress (O.R.C.) Category 3 with raft.
- e) The Sailing Instructions that will not prevail over this Notice of Race

4-PARTICIPANTS

4.1 Boats with O.R.C. Measurement certificate of 2020 may participate in this race, with a length(LOA) equal or greater than nine meters (9 meters).

4.2 The crew will necessarily consist of three crew members, and one of them, at least, will be in possession of the nautical qualification necessary for the government and navigation of the course to be made.

5-ELIGIBILITY

5.1 Participants must meet the eligibility conditions reflected

in regulation 19 of the World Sailing and in the R.F.E.V.

5.2 Participants of Spanish nationality or legal residence in Spain, as well as other nationalities, must be in possession of the federated athlete's license by 2020.

6-PUBLICITY

Point 20.3.1.2 of the World Sailing publicity regulation will apply, the competition regulations of the R.F.E.V. and the prescriptions of the R.F.E.V. to said regulation.

Participants may be required to display advertising according to the advertising code described in section 20.4.1 of this regulation.

7-REGISTRATIONS

7.1 Registration will necessarily be formalized in the attached form, before 7:00 p.m. on January 17th 2020.

7.2 Registration fees are three hundred Euros (€ 300.-) per participating yacht.

7.3 All boats must be available to the RACE COMMITTEE at Moraira Yacht Club before 8:00 p.m. on 20th of January 2020, for inspection and safety control. The presence of a person responsible for the boat at the disposal of the corresponding Committee will be required.

7.4 The registration fees will be sent by means of a nominative check in the name of Club Nautico Moraira or by bank transfer in favor of the same, in this case accompanying, with the inscription, a photocopy of the corresponding receipt of the transfer made to the following banking entity:

7.5 The Registration Forms, together with a photocopy of the deposit by bank transfer or with the nominative check and the documents indicated in section 8.2 must be in the possession of the Organizing Committee before 1:00 p.m. on January 15th 2020.

8-REGISTRATION OF PARTICIPANTS

8.1 The representative of each vessel must sign the Registration Form and submit it to the Race Office of the Moraira Yacht Club, before 1:00 p.m. on January 15th 2020.

8.2 Registration is subject to the presentation, before 7:00

p.m. on January 20th 2020, of the following documents:

- a) ORC valid Measurement Certificate for 2020
- b) Insurance policy in force, covering civil liability (damages to third parties and property), or extension of coverage of civil liability and damages to third parties, up to a minimum amount of six hundred thousand Euros.
- c) Federation sports licenses of the year 2020 for sailors.
- d) List of crew members with number of D.N.I. or passport
- e) Telephone contact number at sea (mobile, satellite, etc.) and contact telephone number on land.
- f) Copy of the Rol and Certificate of Navigability.

8.3 After 8:00 p.m. on January 20th 2020, the registration of a boat that has not submitted the O.R.C.2020 measurement certificate at the race office will not be accepted (modifies rule 78.2 of the RRV).

the course, with an approximate distance of 300 Miles, will be defined by the Race Committee based on the weather conditions that occur on the dates of the race.

11-INSPECTION AND MEASUREMENTS

Safety controls and measurements will be carried out before and / or after the race. The organization may arrange the sealing of the engines of the participating boats.

12-SCORE

Appendix A of the RRV, Low Scoring System will apply.

13-SCORING

At the discretion of the Race Committee, the system described in points 403.2 (Time over Distance) or 403.3 (Time over Time) of Regulation O.R.C. 2020

14-SECURITY

The security of this race is considered as Category 3 with raft and radio beacon, in accordance with the World Sailing Special Regulations governing offshore races

All boats must be equipped with a VHF radio with operating channel 9 and they must also carry a mobile phone on board, whose number they will provide when registering.

Likewise, the Organization reserves the right to install a tracking and / or positioning device in each of the participating boats. All participating boats for the sole purpose of registering for the race agree to install said device free of charge.

15-TROPHIES AND PRIZES

The following trophies and prizes are established:

GENERAL CLASSIFICATION O.R.C.

1st Classified: Trophy and Prize of 3.000.- €

2nd Classified: Trophy and Prize of 2,000.- €

3rd Classified: Trophy and Prize of 1.000.- €

LOWER TIME INVESTED IN THE RACE

1st Classified: Trophy

16-MOORINGS

Boats whose registration is accepted in this race will have a free berth reserved by the MORAIRA YACHT CLUB from one week before to one week after the race. In addition, they will have a free haul-launch and bottom cleaning provided that it is requested in writing at the time of registration and the boat is in the installations of the MORAIRA YACHT CLUB before January 16th 2020.

The MORAIRA YACHT CLUB reserves the right to moor the boat at berths that consider opportune.

17-RESPONSIBILITY

Everyone who participates in the race does so at their own risk and responsibility.

The Organizing Committee or any person or organism involved in the organization of the event, rejects any responsibility for losses, damages, injuries or discomforts that could occur to people or things, both on land and at sea, as a result of participation in the event covered by this race announcement. Attention is drawn to Fundamental Rule 4, DECISION TO RACE, Part 1 of the RRV, which states:

"A boat is solely responsible for its decision to start or not or continue racing."

18-POWERS OF THE ORGANIZING CLUB

The Organizing Club reserves the right to modify this Notice of Race. This Notice of Race is not part of the Rules governing the regatta and may be modified if necessary.
